Office upto 04.10.16 before 4.00 Pm otherwise tender will not be opened.
2. Detailed Estimates/NIT can be seen in the office of Municipal Corporation on any working day during office hours.
3. No any material will be supplied by the Municipal Corporation, Yamuna Nagar.
4. The Commissioner Municipal Corporation, Yamuna Nagar-Jagadhri has right to accept or reject the tenders without assigning any reason.
5. The work shall strictly be Executed in accordance with the specifications of that work.
6. The work shall be got verified by the technical authority & monitoring Committee before its payment Material will also he got checked in to Manufacturer /Authorized dealier godown situated in Haryana on the cost of Agency/Contractor.
7. Time limit of work is **two month..**

Terms and Conditions for Electrical works

1. Conditional Tender and tenders without earnest money are likely to be rejected.
2. Interested bidders can purchase the tender document online from website www.etenders.hry.nic.in.
3. The Commissioner, Municipal Corporation, Yamunanagar-Jagadhri reserves the right to reject or accept any tender in full or part even without assigning any reason.
4. Interested contractors/agencies should deposit their earnest money and tender form fee in the account of Executive Officer Municipal Corporation Yamunanagar-Jagadhri through Bankers Cheque/Demand Draft and Scanned copy to be submitted online along with the bid
5. The agency has to do the work strictly as per specification and further during the inspection of work/testing at any time in future by any Govt. Department/agency, if any deficiency in the work is noticed the agency "personally" will be responsible instead of any Municipal official. The agency is liable to pay for any recovery if found against agency due to deficiency in the work executed by that agency. Moreover the agency will bear the loses personally without any excuses.
6. The work will carry guarantee of 6 months from the date of commissioning for proper functioning in case of any defect or any fault or failure of system of any parts what so ever, the tendered will ,ake good the same including cost of all labour and material, In case, the defect is not rectified with in 48 hours of receipt of complaint the same will be got rectified at the risk and cost of the firm at panel rates i.e. double the expenditure incurred by the department.
7. The security deducted from bills of agency will be refunded after completion of guarantee period.
8. In case of any dispute the orders of worthy Deputy Commissioner, Yamunanagar-Jagadhri will be final.
9. The final payment of agency will be made after inspection of monitoring committee.
10. The quantity of work can be increased /decreased.
11. In case of tender receipt/opening date happens to be holiday the tender shall be received on the next working day on the same timing.
12. No material will be supplied by the department.
13. If at the time of submission of E-tenders, any error occurs due to technical reason of the website Municipal Corporation, Yamunanagar-Jagadhri will not be responsible.
14. Agencies should note that online tenders will be only submitted at the fore said website www.etenders.hry.nic.in as per the detail/instructions uploaded therein.
15. The Contractor/agency has to declare and enclose the documents related to annual turnover more than one Crore Rupees for tenders above Ten Lacs along with PAN/TIN No, address proof and Bank Solvency.
16. Further information can be obtained and scheduled of quantities, the detailed plans and specifications can be seen in the office during the office hours.
17. Tender should be quoted at itemrate/percentage above or below the rate in the details of estimate in the enclosed scheduled and the contractor should state the period within which he agrees to carry out the work.

18. Each tendered shall give proof to the entire satisfaction of the Execution Engineer concerned that he has in his possession Haryana P.W.D specification latest addition failing which his tender shall be liable to be rejected.

19. Rate should be quoted in Hindi or English, otherwise the tender can be rejected.

20. The successful tendered shall have to sign an affidavit to the effect that he has no relation or connection with firm contractor blacklisted by Municipal Corporation, Yamuna Nagar-Jagadhri, from time to time.

21. The earnest money deposited for the tender will not be returned to the contractors/firms till the acceptance of tender or three months, whichever is later.

22. Sales/Works Tax and Income Tax will be deducted from the bills of contractor as per the instruction of the govt.

23. The quality control tests will be got done by department and the material for such tests will be supplied by the contractor free of cost. In case the material is not found up to the requirement, the same will be rejected. Cost of such tests will also be borne by contractor. .

24. Contractor is required to provide cautionary measurement/sign boards etc. during execution of work, and he is fully responsible for any loss/compensation in case of accident, misshapen at the site of work.

25. The Contractor has to start the work immediately and make an agreement with the Municipal Corporation, Municipal Corporation, Yamuna Nagar-Jagadhri within a week after receipt of the work order. It is responsibility of the Contractor.

26. The agency has to complete the work as per specification and within the stipulated time period.

27. The Contractor will be bound to follow all the conditions written in the tender form MW4, D.N.I.T. and tender notice.

28. Before starting the work, the agency has to provide the samples of all the materials to be used in the execution of the work.

29. The warrantee of LED light will be one years from the date of installation.
