- (v) The firms which qualify technical criteria will be eligible for opening of financial bids.
- (vi) Commissioner, Municipal Corporation, Ynr-Jag reserves the right to accept/reject or cancel any tender/Bid without assigning any reason.
- (vii) Interested tenderers should have at least 5 years of experience in relevant field and shall have to supply certificate for at least four successful works done.
- (viii) Turn over of the bidders should be at least 3 crores per years or 5 crores in average for last 3 years.

Terms & Conditions to be fixed:-

1. A dwelling unit shall mean any entire building of one or more stories and all families/persons residing therein related to the owner. The tenant will be considered as a separate dwelling unit.
2. All dwelling units shall be shown bifurcated each in General, B.C. & S.C category separately and in blocks of 500-1500 population.

3. Mode of Payment:-

- a. 45% payment shall be released after satisfactory submission of report of half of the tentative dwelling units i.e 55000 Nos. and 45% payment shall be released after submission of satisfactory report of balance unit.
- b. The balance 10% payment shall be released within 30 days of the satisfactory completion and submission of the report of the project.
- c. A Security of 5% shall be deducted from the running bills which will be released after 90 days of submission of the work.
4. The time period for the completion of this work is 3 months to be reckoned w.e.f. Dt of work order.
5. If the work will not completed in stipulated time frame then a penalty @1/2% (0.5%) per week or part thereof the contract value shall be imposed up to maximum limit of 5%.
